

# LIQUID BROMATROL

For the control of rats and mice

Contains 0.1% w/w (1.0 g/l) Bromadiolone

## DIRECTIONS FOR USE

Bait labels must be affixed to containers to which the prepared bait is transferred to facilitate its use. Always protect baits well so as to protect from the prevailing weather and to prevent access by humans, domestic animals and wildlife. Shake well before use.

(a) Liquid baits - Dilute 50ml of concentrate in 950ml clean water. Mix well and use in suitable containers. The liquid bait is best used in conjunction with conventional anticoagulant baits and in dry locations where no other source of water is available.

(b) For use with whole seeds and cereals - Add 50ml of undiluted concentrate to 1kg of bait base.

(c) For use with biscuit crumbs etc.- Dilute 50ml of concentrate in 150ml of clean water. Mix well. Add mixture to 800g of bait base.

**FOR RATS :** Place prepared bait in protected locations where rats are running or feeding. Use up to 500g prepared bait per baiting point depending on infestation level (more may be necessary in severe infestations). Place the baits in runs or near harbourages to offer maximum opportunity for feeding. Inspect baits at appropriate intervals. Replenish bait as necessary until no more is taken.

**FOR MICE :** Use up to 10g bait, in a bait box or tray where appropriate. Place baits in protected situations, where mice are running and feeding. Inspect baits at appropriate intervals. Replenish bait as necessary until no more is taken. Once the rodent population is completely controlled, do not place further rodenticide until a new infestation is identified.
