### 4) FIRST AID MEASURES

General advice: The nature of this product, when contained in commercial packs, makes spillage unlikely. However, if significant amounts are spilled then the following advice is applicable. Move out of dangerous area. If the patient is likely to

become unconscious, place and transport in stable sideways position. Remove contaminated clothing immediately.

Skin contact:

Wash off immediately with plenty of soap and water, if available polyethyleneglycol 400, subsequently rinse with

water. Take medical treatment if irritation develops and persist.

Eye contact:

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if

present, after the first 5 minutes, then continue rinsing eye. Get medical attention if irritation develops and persists.

Ingestion:

Call a physician or poison control center immediately. Do NOT induce vomiting.

## NOTES TO PHYSICIAN:

Treatment:

Treat symptomatically.

Monitoring of respiratory and cardiac functions.

In case of ingestion gastric lavage should be considered in cases of significant ingestions only within the first 2 hours.

However, the application of activated charcoal and sodium sulphate is always advisable.

### 5) FIRE FIGHTING MEASURES

Suitable extinguishing media:

Water spray, carbon dioxide (CO<sub>2</sub>), alcohol resistant foam, sand.

Extinguishing media which should not be used for safety reasons: High volume water jet.

Specific hazards during fire fighting:

In the event of fire the following can be released: Carbon monoxide (CO).



Special protective equipment for fire-fighters:

In the event of fire and/or explosion do not breathe fumes.

Use self-contained breathing apparatus.

Further information:

Contain the spread of the fire-fighting media.

Do not allow run-off from fire fighting to enter drains or water courses.

#### 6) ACCIDENTAL RELEASE MEASURES

Personal precautions:

Avoid contact with spilled product or contaminated surfaces.

Wear personal protective equipment. Unprotected persons must be kept away.

Environmental precautions:

Do not allow to get into surface water, drains and ground water.

Methods for cleaning up:

The nature of this product, when contained in commercial packs, makes spillage unlikely. However, if

significant amounts are spilled then the following advice is applicable.

Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder). Clean contaminated floors and objects thoroughly, observing environmental regulations.

#### 7) HANDLING AND STORAGE

Handling:

Advice on safe handling: No specific precautions required when handling unopened packs/containers; follow relevant manual handling

Requirements for storage areas and containers: Keep containers tightly closed in a dry, cool and well-ventilated place.

Store in original container.

Store in a place accessible by authorized persons only.

Advice on common storage:

Keep away from food, drink and animal feedingstuffs.

Personal protective equipment:

In normal use and handling conditions: Wear rubber gloves.

In all other cases the following recommendations would apply:

Respiratory protection: No personal respiratory protective equipment normally required. Respiratory protection should only be used to control residual risk of short duration activities, when all reasonably practicable steps have been taken to reduce exposure at source e.g. containment and/or local extract ventilation. Always follow respirator manufacturer's

instructions regarding wearing and maintenance.

Hand protection:

Wear CE Marked (or equivalent) nitrile rubber gloves (minimum thickness 0,40 mm). Wash when contaminated. Dispose of when contaminated inside, when perforated or when contamination outside cannot be removed.

Wash hands always before eating, drinking, smoking or using the toilet.

Eye protection:

Wear goggles conforming to EN166 (Field of Use 5 or equivalent).

Skin and body protection: Wear standard coverall and type 6 suit. Wear two layers of clothing wherever possible. Polyester/cotton or cotton overalls should be worn under chemical protection suit and should be professionally laundered

frequently.

Avoid contact with skin, eyes and clothing.

Keep working clothes separately.

Wash hands before breaks and immediately after handling the product. Remove soiled clothing immediately and clean thoroughly before using again. Garments that cannot be cleaned must be destroyed (burnt).
